I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

was filed in the office of the Secretary of State on the **Sixth** day of **June** A. D. One Thousand Nine Hundred **Sixty-one** and is duly recorded on Film No. **114** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103 and Sections 30-1001 to 30-1005, inclusive, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **perpetual existence** from the date hereof, with its registered office in this State located at **Boise** in the County of **Ada,** and as such are subject to the rights, privileges and limitations granted to Non-Profit Cooperative Associations as provided in Chapter 10, Title 30, Idaho Code.

ARTICLES OF INCORPORATION
OF
THE IDAHO GENEALOGICAL SOCIETY, INC.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, each of whom is a bona fide resident and citizen of the State of Idaho and the United States of America, and each of whom is a natural person of full age, have this day voluntarily associated ourselves together for the purpose of forming a non-profit corporation under the laws of the State of Idaho, and we do hereby certify:

ARTICLE I

The name of the corporation is The Idaho Genealogical Society, Inc.

ARTICLE II

The location of its principal place of business and the registered office of this Corporation is hereby designated as Boise, Ada County, Idaho.

ARTICLE III

The Corporation shall have perpetual existence.

ARTICLE IV

This Corporation is formed as a non-profit, non-sectarian, non-political, non-commercial organization, and the objectives and purposes of this Corporation are to give mutual assistance in genealogical research, to collect and preserve genealogical records, and to do all things to the same extent as natural persons might or could do in the furtherance of said objectives and purposes.

ARTICLE V

The Corporation shall issue no stock, but shall issue membership certificates to each member of the Corporation. Such membership certificate shall not be assignable, and no member of the incorporation can have or acquire a greater interest in the corporation than any other member.
